TOWN OF ONEIDA, OUTAGAMIE COUNTY

JULY 10, 2024

The meeting was called to order at 7:00 P.M. by Scott Schaumberg.

Al Krause made a motion to approve the Monthly Town Board Meeting Minutes from June 12, 2024 without corrections. Terry Hock second the motion. Motion carried

Terry Hock made a motion to approve the vouchers numbered 35990 thru 26005 and 7 EFT online payments. Al Krause second the motion. Motion carried.

Outagamie County Sheriff Department; No Outagamie County Sheriff present.

CSM review for Hock/Wisconsin Michigan Pipeline Co- Terry Hock made a motion to approve the new CSM for Hock/ Wisconsin Michigan Pipeline Co. Al Krause second motion. Motion carried

Immaculate Conception Cemetery- Veteran Reimbursement. Al Krause made a motion to approve the Immaculate Conception Cemetery Veterans Reimbursement. Terry Hock second. Motion carried

Operator License-Kathryn Lillge. Al Krause made a motion to approve the operator license for Kathryn Lillge. Terry Hock second motion. Motion carried.

Fire Department Report given by Glen Olson; June Report (8 fire calls) Fish Creek Rd; Lift assist. Cooper Rd; Tree on Road. Cty E and Cty J; Tree knocked wires down across the road. Van Boxtel and Mullen Rd; 1 car accident. No transport. Cty E and Hwy 55; 1 car rollover. No transport. Cooper Rd and Cty U; Vehicle fire. Park Drive; Gas leak. No findings. Park Drive; second call for gas leak. No findings.

May training was for a scenario of a person pinned under a culvert and rescue training. One tender and two firefighters went to Freedom for water movement training.

July Report (9 fire calls) Cty E; skid loader fire. Poplar Ln; Tree across road and wires down. Cty E and Fish Creek; 2 car accident. 1 transport by helicopter/ambulance. Path of the Wolf; Missing ½ year old child. Cty Y; House fire. Started in the kitchen from the stove. Cty E and Cty EE; Boat fell off trailer with gas leaking. Cty EE; Motorcycle accident. 1 transported. Moore and Ranch Rd; Motorcycle accident. 2 transported. Nicholas Fire; MABAS call for garage fire.

June Training was for water movement with 3 tenders and 2 engines. Fire department received final payment for air packs.

First Responder Report given by County Rescue and reported by Kelly Hill for June 2024; Total calls= 24. Advanced Life Support =14. Basic Life Support =7. Non-transports =7 (29%). Mutual Aid=0. EMRs on-scene=4. Average Response time 8.1 min.

Open Discussion – Limit 3 minutes per person

Craig Beyer discussed concern on Moore Rd. No outlet sign is hidden by cattails. Resident is noticing a lot of traffic on the dead end. Scott Schaumberg stated the town maintenance will evaluate and improve the situation.
