MONTHLY TOWN BOARD MEETING

The meeting was called to order at 7:05 P.M. by Scott Schaumberg.

Also Present: Glen Olson, Riley Olson, Lori Olson, Ken Olson, Barb O'Connor Schevers, Pat Cornelius, Cheryl Van Den Berg and Cody Melchert

Scott Schaumberg stated the Pledge of Allegiance was previously done and therefore onto the next agenda item.

Scott Schaumberg made a motion to approve the Monthly Town Board Meeting Minutes from April 12, 2023 without correction. Al Krause second the motion. Motion carried.

Scott Schaumberg made a motion to approve the vouchers numbered 25602 thru 25635 and 3 EFT's. Al Krause second the motion. Motion carried.

Outagamie County Sheriff Department; No Sheriff present. Kelly Hill stated that her brother's trailer was stolen from his driveway on Rice Rd. Scott Schaumberg reminded residents that with the change in season to drive with caution and watch for farm equipment, UTV's, and children.

Town Recommendation Form-Nick VanDeHei; TABLED due to no one present to discuss details of agenda item.

Approval of Pavilion Rental for car/auto competition-Cody Melchert. Cody Melchert discussed his event to rent the pavilion that is scheduled for June 24, 2023. Cody asked for at least 5 garbage bins. Cody also verified that there will be 2 porta-potties on the grounds. Cody Melchert and Fire Chief, Glen Olson discussed the event using the Fire Department raffle license. Glen Olson stated the Fire Department would allow the usage of the raffle license. Scott Schaumberg made a motion to approve the Pavilion Rental for the Car/Auto Competition on June 24, 2023. Al Krause second the motion. Motion carried.

Temporary Class "B" License-Immaculate Conception Parish on August 20,2023. Scott Schaumberg stated he talked with Rich Van Den Eng in regards to the event. The town of Oneida has approved this license in the past and supports the event. Scott Schaumberg made a motion to approve the Temporary Class "B" License-Immaculate Conception Parish on August 20,2023. Al Krause second the motion. Motion carried.

Operator License on August 20,2023 for Brooke Ellingson. Scott Schaumberg made a motion to approve Brook Ellingson operator license for August 20,2023 motion. AL Krause second. Motion carried.

Temporary Class "B" License- Fire Department Picnic June 4, 2023. Scott Schaumberg made a motion to approve the Temporary Class "B" License for the Fire Department Picnic June 4, 2023. Al Krause second the motion. Motion carried.

Town of Oneida First Responder Account. Scott Schaumberg stated that the Town of Oneida First Responder account needs to change account access and address. The account was previously maintained by Kurt Nackers who is now deceased and Rachel McInnis, who is no longer an active First Responder. Scott Schaumberg asked Glen Olson what his thoughts are as the Fire Chief of who should maintain the account. Glen Olson stated that this account was a Town budgeted account when we had active first responders. Glen also stated that the First Responders never did fundraising for their finances. The department ran off of the town budget, therefore, the money is the towns due to previous budgeting amounts. Al Krause made a motion to keep the account in

the town's budget and change the names and address to the Town Clerk and Chairman. Scott Schaumberg second the motion. Motion carried.

Ranch Lane- Scott Schaumberg stated that in the Town of Osborn on the previous Ranch Lane there is a barricade and "Private Road" signs. Scott Schaumberg stated that he submitted the winter maintenance invoice to the Town of Osborn. Kelly Hill stated she is in the process with the Register of Deeds of processing the previously approved Ordinances of Ranch Lane. Scott Schaumberg TABLED

Fire Department Report given by Fire Chief Glen Olson. (4 calls) County Rd U and Fish Creek; 2 car accident with 1 transport. County Rd Y; 1 vehicle hit tree. No transport. Ranch Rd; House fire assisted by Seymour Fire. Service Rd; Lift assist on request from County Rescue.

Fire Department News; April Training; Driving Course and Pumper Certification. In April, the fire department had a 2 % Dues Audit and everything went well. Audit is completed every 3-5 years. September 9th, the Fire and Iron Motorcycle Club is going to be starting their ride at the Town of Oneida Fire Department. This is a fundraiser that will benefit both the club and fire department. The Fire and Iron Motorcycle Club donates to a youth burn center and the fire department will be selling meal tickets and refreshments. The club estimates 60-80 people at the event. This event is open to the public and the fire department is considering doing their open house that day also.

First Responder Report; Report provided by County Rescue for April. Reported by Kelly Hill. February. (19 calls) 10 Advanced Life Support. 2 Basic Life Support. 6 (32%) non-transport. 1 Mutual Aid. 6 EMRs on scene.

Open Discussion – Limit 3 minutes per person

Pat Cornelius stated she lives on Johnson Rd. Pat stated her concern of the speed on Johnson Rd. Pat stated that there is a lot of pedestrian traffic on that road and thinks that the speed should be lowered. There is currently a speed limit sign that is 15mph. Scott Schaumberg asked Pat Cornelius who put that road sign up. Scott Schaumberg stated that Johnson Rd is a Town owned road and the town did not put the 15mph speed limit sign up. Scott Schaumberg stated that 15 mph is way too slow for a town road. Kelly Hill stated that in order for the road to be 15 mph it needs to be considered a rustic road. State statute dictates what a rustic road can qualify for and Johnson Road does not meet any of those requirements. Kelly Hill also stated that the Town of Oneida has an ordinance that if a Town of Oneida road is not posted the speed limit is 55 mph. Scott Schaumberg asked Pat Cornelius what she thinks would be an ideal speed limit on Johnson Rd. Pat Cornelius stated she'd like it to be 35mph. Scott Schaumberg stated that would be a fair speed limit. The road is short and winding and that would be acceptable. Al Krause stated that the Town will look into what the process is to approve the speed limit to be 35 mph on Johnson Rd. Scott Schaumberg asked the town maintenance, Riley Olson, to remove the 15mph speed limit sign and put up 35mph.

Ken Olson stated that his dad, Hank Olson, was going through some old fire department paperwork and found an article. Lori Olson had copies of the article and dispersed copies to residence. The article was edited by Barb O'Connor-Schevers from a speech that William Van Boxtel gave. The article was in regards to the Building Dedication of New Fire Station in 1982.

Scott Schaumberg made a motion to adjourn at 7:59 P.M. Al Krause seconded the motion. Motion carried.
