TECHNICAL SPECIFICATIONS:

HOT MIX

Pulverize asphalt pavement and the minimum of 4 inches of base

Place a 3 1/2-inch compacted asphalt mat in two lifts with a 2" 3LT 58-28S Lower Layer and 1.5" 4LT 58-28S upper Layer.

Asphalt Concrete Pavement will meet the most Current State of Wisconsin Department of Transportation Standard Specification of Highway and Structure Construction, Section 460-E1

Projected start date for project is May 1, 2023 and deadline is September 30, 2023.

Insurance: The contractor shall furnish and deliver to the Town of Oneida a certificate of insurance for worker's compensation and an umbrella certificate of liability and property insurance in the minimum amount of \$1,000,000.00 prior to awarding bids.
