

11.03 RIGHT OF WAY EXCAVATION AND CULVERT INSTALLATION

(1) No excavating, boring, filling, or changes of any kind shall be made in the Town Road right-of-way without first obtaining the written authorization from the Town Chairman or his designee.

(2) No culvert shall be installed except with a written permit from the Town Chairman or his designee; said permit shall not be granted until the Town Chairman or his designee views the property and determines the diameter, location, and elevation for said culvert. The minimum length shall be ~~32~~ feet and end walls are required.

(3) The surface of the driveway connecting with the rural-type highway sections shall slope down and away from the highway shoulder a sufficient amount and distance to preclude ordinary surface water drainage from the driveway area flowing onto the roadway bed.

(4) Driveway side slopes shall be of earth material only. No concrete, stone or bituminous side slopes shall be constructed.

(5) All culverts shall be of galvanized steel; no plastic culverts shall be permitted in the Town.

(6) The installation of the culvert shall be made without danger or interference with traffic using the Town Road.

(7) Road surfaces, slopes, shoulders, ditches and vegetation that has been disturbed shall be restored.

(8) No blind entrances shall be installed unless specifically authorized by the Town Chairman or his designee. The size and location of all blind entrances shall be determined by the Town Chairman or his designee.

(9) The Town Board reserves the right to make such changes, additions, and relocations within statutory limits on the right-of-way as may, at any time, be considered necessary to permit the relocation, reconstruction, widening and maintaining of the road, or to provide proper protection to life and property on the road.

(10) The entire cost of installing and maintaining the culvert shall be borne by the applicant. The work shall be carried out in a manner satisfactory to the Town Chairman or his designee.

(11) The installation of the culvert shall be completed within ninety (90) days of the date of the permit. A final inspection shall be made by the Town Chairman or his designee. Should the installation of said culvert not be in accordance with Town standards, the Town Chairman or his designee shall order the work performed properly, and the cost of said repairs shall be charged against the property pursuant to Wisconsin Statute 66.60(16).

(12) All property owners installing a culvert under a culvert permit agree to hold harmless the Town of Oneida and its duly appointed agents and employees against any action for personal injury or property damage as a result of the installation of said culvert.

(13) A fee of Twenty-Five Dollars (\$25.00) shall be paid for a culvert permit.

ORDINANCE NO. 2000- 2

AMENDMENTS TO
STREET AND ROAD CONSTRUCTION

The Town Board of the Town of Oneida do ordain as follows:

SECTION I. Section 11.02 (2)(d) of the Town of Oneida Code of Ordinances is hereby repealed and recreated to read as follows:

11.02 SPECIFICATION:

(2) Material. All road beds shall be constructed with the following being the minimum materials used:

(d) Blacktop of 22 feet with a 3 inch thickness.

SECTION II. Section 11.03(2) of the Town of Oneida Code of Ordinances is hereby repealed and recreated to read as follows:

11.03 RIGHT OF WAY EXCAVATION AND CULVERT INSTALLATION

(2) No culvert shall be installed except with a written permit from the Town Chairman or his designee; said permit shall not be granted until the Town Chairman or his designee views the property and determines the diameter, location and elevation for said culvert. The minimum length shall be 32 feet and end walls are required.

(3) A cul de sac is to be 100 feet in diameter.

SECTION III. Section 11.03(14) is hereby created to read as follows:

11.04 RIGHT OF WAY EXCAVATION AND CULVERT INSTALLATION.

(14) All top soil shall be removed before construction of any road bed or installation of a culvert.

SECTION IV. This Ordinance shall take effect upon passage and publication.
