

MONTHLY TOWN BOARD MEETING
TOWN OF ONEIDA, OUTAGAMIE COUNTY
OCTOBER 12, 2022

The meeting was called to order at 7:00 P.M. by Scott Schaumberg.

Present were: Scott Schaumberg, Al Krause, Terry Hock and Kelly Hill
Also Present: BJ O'Connor-Schevers, Glen Olson, Luann Skarlupka, Lori Olson and Ken Olson.

Scott Schaumberg led in the Pledge of Allegiance.

Terry Hock made a motion to approve the Monthly Town Board Meeting Minutes from September 14, 2022 without corrections Al Krause second the motion. Motion carried.

Al Krause made a motion to approve the vouchers, numbered 25304 thru 25327 and 3 EFT's. Terry Hock second the motion. Motion carried.

Outagamie County Sheriff Department: No Sheriff present to give report. Resident concern on Pearl St of vehicles not stopping for stop signs.

Seminary Road speed limit: Scott Schaumberg stated a request was presented from Oneida Nation to change the speed limit on Seminary Rd to 35mph. Seminary Rd is the Town of Oneida Ordinance with a speed limit of 45mph. Speed reduction signs are posted in the School Zone. Scott Schaumberg stated that at this time there will not be a change to the speed limit.

Terry Hock made a motion to transfer \$3200 from the Capital Expense Budget to Elections Budget. Al Krause second the motion. Motion carried. Proposed transfer is due to four elections in one year. Terry Hock made a motion to transfer the \$5584.27 from the Capital Expense Budget to Town Hall Budget. Al Krause second the motion. Motion carried. Proposed transfer was determined by an average cost of Town Hall Expenses per month and multiplied by three for the remaining three months of the year. Terry Hock made a motion to transfer \$247,645.80 from ARPA Local Fiscal Recovery Funds Budget to Highway Budget. Al Krause second the motion. Motion carried. Proposed transfer was planned when completing the road bids for funding. Discussed possible budget transfer from Capital Expense Budget to Highway budget. Kelly Hill has a meeting with KerberRose on 10/17/2022 to discuss the need for transfer.

Discuss Budget and set November Date. Al Krause made a motion to approve the 2022 Proposed Budget and set the 2022 Budget Proposed Budget Hearing on November 9, 2022 at 7:00PM with November Monthly Meeting to follow. Terry Hock second the motion. Motion carried.

Air packs for Fire Department- TABLED will discuss the budget hearing.

Fire Department News; September Training Annual Hose Testing. Open House and Fire Prevention had about 15 people on Friday and 20 people on Saturday.

Fire Department Report given by Fire Chief Glen Olson. (10 calls) Olson Rd; Tractor roll over. No transport. Seminary Rd; Trailer hit power pole and wires down. Oneida Nation Elementary School; Fire Alarm tripped. Old Seymour Rd; Shed Fire. Oneida Nation Elementary School; Fire Alarm. General alarm. Cty H Rec Center; Fire Alarm. Something sprayed in the bathroom set off the alarm. Cty H Rec Center; Fire Alarm tripped. Pearl St & Cooper Rd; 2 car accident and clean up no transport. Sand Hill Circle; Gas smell in house. Sand Hill Circle; Car Fire.

First Responder Report given by County Rescue and reported by Kelly Hill; Total calls=30. Advanced Life Support = 16. Basic Life Support = 2. Non-transport = 12 (40%). Mutual Aid= 0. EMRs on-scene=7.

Open Discussion – Limit 3 minutes per person

Barb O'Connor-Schevers and Ken Olson discussed the concern of a pothole on Seminary Rd. located on the North side of the road and west of the bridge.

Glen Olson discussed the concern of potholes on Olson Rd. between Hwy 54 and Pearl St.

Ken Olson suggested displaying a poster or having applications available on Election Day to get the word out to residents about the need for volunteer EMT's, First Responders and Fire Department. Glen Olson and the Fire Department will pursue suggestions and will have applications and information available on Election Day.

Al Krause made a motion to adjourn at 8:32 P.M. Scott Schaumberg seconded the motion. Motion carried.
