

MONTHLY TOWN BOARD MEETING
Town of Oneida, Outagamie County
December 10, 2025

Call to Order: The meeting was called to order at 7:02 P.M. by Scott Schaumberg.

Present were: Scott Schaumberg, Al Krause, Terry Hock and Kelly Hill

Pledge of Allegiance: Led by Chairperson Scott Schaumberg.

Read, correction and approval of the 2026 Proposed Budget Hearing on November 12, 2025, the Special Town Meeting of Electors on November 12, 2025, the Monthly Town Board Meeting Minutes on November 12, 2025 and the CGA Meeting Minutes on December 8, 2025. Terry Hock motioned to approve the 2026 Proposed Budget Hearing on November 12, 2025, the Special Town Meeting of Electors on November 12, 2025, the Monthly Town Board Meeting Minutes on November 12, 2025 and the CGA Meeting Minutes on December 8, 2025 with the correction of adding Tahassi Hill to who was present at the meeting. Al Krause seconded the motion. Motion carried.

Approval of Vouchers: Terry Hock motioned to approve the vouchers numbered 26374 through 26385 and 11 EFT online payments. Al Krause seconded motion. Motion carried.

Outagamie County Sheriff Department- Resident Concerns: Depty Martinez was present and reported no current concerns. No resident concerns were noted

Amendment to 2025 Town Budget: Al Krause motioned to approve Resolution No. 2025-05 Amendment to 2025 Town Budget. Budget transfer of \$4,500 from Capital Expense to Clerk Supply/Wage account. Terry Hock seconded the motion. Motion carried.

Village of Hobart: Village President Rich Heidel addressed concerns raised by Chairperson Schaumberg regarding statements made by a Village of Hobart Trustee on social media. Mr. Heidel stated the Village Administrator was unable to attend due to a health issue. Mr. Heidel clarified that the statements do not represent the Village of Hobart or its staff and emphasized the positive mutual aid relationship between the Town of Oneida and the Village of Hobart, particularly with fire services.

Mr. Heidel outlined three actions to address the matter: (1) discussion at an upcoming Village Board meeting; (2) training or orientation for board members and staff regarding social media use; and (3) development of a social media policy for board members and staff. No board action was taken.

Annual Fire Department Personnel/Town Employees Appreciation Bonus: Al Krause motioned to approve the Annual Fire Department Personnel/Town

Employees \$50 cash bonus for 27 fire department personnel and 7 town employees. Terry Hock seconded the motion. Motion carried.

Employee Wages for 2026: Chairperson Schaumberg opened discussion regarding employee wages. Clerk/Treasurer Kelly Hill summarized duties, accomplishments, and comparable wages. Scott Schaumberg motioned to set wages effective January 1, 2026, as follows: Riley Olson – \$25.00/hour; Glen Olson – \$25.00/hour; Kelly Hill – \$27.00/hour; Dave Dill – \$20.00/hour. Terry Hock seconded. Motion carried. Glen Olson suggested Dave Dill operate the pay loader during larger storms.

Fire Department Report: Provided by Glen Olson; (9 calls) On 11/16, Cty EE; Grass fire. On 11/17, VanBoxtel Rd; Grass fire. On 11/17, Park Dr; Gas Leak. On 11/22, Deer Path Dr; Smell of burning wires. On 11/24, Pulaski; MABAS call. 1 tender. 2 personnel. Fire Department is concerned about the delay from Brown and Outagamie County dispatch for MABAS calls. On 11/25, Cty VV; Brush burning, controlled burn. On 12/2, Evergreen Dr; Smell of gas. On 12/3 Cty E & Fish Creek Rd; 2 car accident. 2 people transported. On 12/9, Cty E; Van in ditch.

December Election of Officers; Glen Olson, Chief. Kurt Olson, Assistant Chief. Kyle VandenLangenberg, secretary. Anna Maass, Treasurer. New board member, Gerald Flores.

Fire Department purchased and received 500ft of new hoses that failed last inspection with funds from annual fire department picnic.

First Responder Report: Provided by County Rescue for November 2025; Total calls = 23. Response Time - 12:05 min. Calls included: (4) Breathing Problems. (3) Fall Victims. (2) Abdominal Pain. (2) EMS Requested Law Enforcement. (2) Medical Alarms. (1) Altered Mental Status. (1) Back Pain. (1) Chest Pain. (1) Convulsions/seizure. (1) Headache. (1) Heart Problem. (1) Overdose/Poisoning. (1) Stroke. (1) Traffic Accident. (1) Transfer-Non-Hospital to Hospital.

Al Krause thanked Mr. Heidel for County Rescue being housed at the new fire station on South Pine Street, noting improved response times and positive impact on our community.

Scott Schaumberg asked how Village of Hobart is on first responders. Rich stated they have only a handful of first responders. Same is true with volunteer fire personnel. Town of Oneida Fire Chief, Glen Olson, stated there used to be a waiting list.

Melinda Danforth representing Oneida Nation provided updates and requested further information on the upcoming fire truck time line for the Volunteer Fire Department along with the 2026 road project..
