Read, correct, and approve the Cooperative Governmental Agreement Meeting with Oneida Nation Minutes on September 9, 2025: Terry Hock motioned to approve Monthly Town Board Meeting Minutes from September 9, 2025, without correction. Al Krause seconded the motion. Motion carried.

Approval of Vouchers: Terry Hock motioned to approve the vouchers numbered 26332 through 26346 and 10 EFT online payments with verification from clerk of check number 26332 for Carew invoice. Al Krause seconded motion. Motion carried.
