**Fire Department Report:** Provided by Glen Olson; (7 calls) Olson Rd; Tree on Road. Cty E & Fish Creek; Tree in roadway. Old Seymour Rd; Tree on wire and broke wire. Oneida High School; Fire Alarm going off. False alarm. Pulaski: MABAS call. 1 tender. Cty EE; A/C unit fire in apartment. Lambie Rd; CO2 detector going off. No findings.

May Training focused on search and rescue. 12 air packs and compressor purchased from Oshkosh Fire and Police Equipment was funded by Oneida Nation. Additional air packs were ordered through Oshkosh Fire and Police. Additional air packs and equipment were ordered using donated funds accumulated over the past five years from a local business intended for air packs.

**First Responder Report:** Provided by County Rescue for May 2025; Fall Victim (8). Breathing Problems (4). Diabetic Problem (4). Medical Alarm (3). Sick Person (3). Chest Pain (2). Traumatic Injury (2). Unknown Problems (2). Abdominal Pain (1). Assault (1). Total calls = 10 Response Time - 10 min.

**Open Discussion –** Limit 3 minutes per person

Ken Olson (Hank Olson Construction):

- Graded Henn Lane; reported no gravel remains.
- Completed grading of Van De Bruggen Lane, with four loads of stone added.
- Completed ditch cleaning on Ranch Road. Scott Schauumberg confirmed with Outagamie County Highway Department that the remaining portion of Ranch Road ditch cleaning is on their 2025 work order through Oneida Nation.

Town Road Maintenance Discussion:

- McCabe Road: Large debris piles along east side; recommend town maintenance removal prior to mowing and for safety.
- McCabe Road is noted as needing urgent pot hole repair and discussion of the road in most need of road work.
- Hanson Road project started this week and will be completed by MCC.
- After the billing cycle, town will evaluate funds for additional road work.
- Moore Road: Smear patching planned for 2025.

Trees in the right-of-way are a safety concern—blocking sunlight, increasing winter salt usage. Discussion on contracting out tree removal and chipping services due to the large quantity of trees that need attention. Fish Creek Road was discussed as the priority.

Town of Oneida has provided road information to Oneida Nation for grant application and funding for Seminary Rd, Old Seymour Rd, and Ranch Rd (portion). No current update from Oneida Nation.

**Adjournment:** Terry Hock motioned to adjourn at 7:31 P.M. Al Krause seconded the motion. Motion carried.
