

MONTHLY TOWN BOARD MEETING

Town of Oneida, Outagamie County

November 12, 2025

Call to Order: The meeting was called to order at 7:45 P.M. by Scott Schaumberg.

Present were: Scott Schaumberg, Al Krause, Terry Hock and Kelly Hill

Also Present: Chet Olson, Ken Olson, Lori Olson, Cheryl VanDenBerg, Jason Krahn, Outagamie County Officer Thegel

Pledge of Allegiance: Led by Chairperson Scott Schaumberg.

Read, correct, and approve the Monthly Town Board Meeting Minutes on October 8, 2025: Terry Hock motioned to approve Monthly Town Board Meeting Minutes from October 8, 2025, without correction. Scott Schaumberg seconded the motion. Motion carried.

Approval of Vouchers: Al Krause motioned to approve the vouchers numbered 26361 through 26370 and 12 EFT online payments. Al Krause seconded motion. Motion carried.

Outagamie County Sheriff Department- Resident Concerns: General discussion regarding a possible concern of an individual living in a camper on Ranch Rd as this goes against Town Ordinances.

Amendment to 2025 Town Budget: Al Krause motioned to approve Resolution No. 2025-04 Amendment to 2025 Town Budget. Budget transfer \$10,833.00 from Capital Expense into Insurance and Bond Expense. Budget transfer \$30,000 from Capital Expense to Highway Expense account. Terry Hock seconded the motion. Motion carried.

Fire Department Report: Provided by Glen Olson and presented by Chet Olson; (9 calls) On 10/9, Car/deer on Cty EE. On 10/9, CO2 call on Legacy Ln. Faulty detector. On Oct 17, car rollover on CTY VV. On Oct 20, false alarm on Water Circle Pl. On Oct 31, house lockout on CTY U. On Nov 2, MABAS Nichols house fire. 1 engine and 6 person. On Nov 2, Cty U/EE car fire. On Nov 2, Cty EE control burn. On Nov 8, stand by on Cooper Rd and Pearl St. On Nov 8, ift assist with Oneida Police.

This month's training was hose testing; two hoses failed and will be replaced.

First Responder Report: Provided by County Rescue for October 2025 and presented by Clerk; Total calls = 15. Response Time - 8.45 min. Fall Victim (3). Sick Person (3).

Altered Mental Status (1). Assault (1). Back Pain (1). Breathing Problems (1). Chest Pain (1). Hemorrhage/Laceration (1). Intoxicated (1). Medical Alarm (1). Psychiatric Problems (1). Standby -Fire (1). Traffic Accident (1). Transfer - Non-Hospital to Hospital (1). Unconscious/Fainting (1).

Open Discussion – Limit 3 minutes per person

Driveway Inquiry - Chairperson Scott Schaumberg reported that requested driveway install does not require a culvert due to its location at the top of a hill with no ditch or drainage needs. Clerk verified with Outagamie County Development and Land along with Highway Department; no permits or concerns were identified.

Road Concerns on Meadowlark Rd & VanBoxtel Rd - Resident Jason Krahn discussed the need for repair, resurfacing or maintenance of Meadowlark Rd and VanBoxtel Rd. Residents' evaluation of VanBoxtel Rd of being only 16ft wide in some areas with 4-5 inch drop-offs on the shoulder, causing safety concerns. Meadowlark Rd has a 4-inch drop near the address of W758 Meadowlark along with the overall condition of road.

Chairperson Scott Schaumberg reviewed the 2026 road project, including the collaboration with Oneida Nation in reconstructing 7.5 miles of roads and culvert replacement, which include Old Seymour, Seminary and a portion of Ranch Rd. The culverts have already been installed. The Town has the budget for 1 mile of reconstruction of a road. The 2026 project will benefit with the amount of miles that will be completed.

Additional notes:

McCabe Rd condition discussed, including maintenance options.

The town did complete locations of patch smearing, cold mix wedging and cold patching throughout 2025.

Town maintenance will place gravel at Meadowlark drop as a temporary winter fix; reevaluation in 2026.

Boom mower / Brush cutter update - Cheryl Vandberg requested an update. Terry Hock reported the mower was repaired, but is currently out of service again. Chairperson Schuamberg noted contracted trimming occurred on Reuden Rd and Bodart Ct. Dry ditch conditions will allow for additional trimming. Cheryl reported a longstanding request for trimming the curve of Ray Rd that remains incomplete and is a safety concern.

Road maintenance requesting attention:

Meadowlark - Temporary gravel fill near W758 Meadowlark

VanBoxtel Rd - Shoulder repair

Ray Rd - Curve mowed/brush cutting

McCabe Rd- Large pot hole in the middle of the road

Vans Rd- Shoulder repair

Cheryl Vandenberg reported bags of garbage on corner of Johnson Rd.

The clerk provided residents with upcoming tax bill information and encouraged use of www.outagamie.org to view, pay or print tax receipts
