## MONTHLY TOWN BOARD MEETING Town of Oneida, Outagamie County May 14, 2025

Call to Order: The meeting was called to order at 7:09P.M. by Scott Schaumberg.

Present were: Scott Schaumberg, Al Krause, Terry Hock and Kelly Hill Also Present: Barb O'Conner Schevers, Ken Olson, Lori Olson, and Craig Beyer.

Pledge of Allegiance: Led by Chairperson Scott Schaumberg.

**Read, correct, and approve the Monthly Town Board Meeting Minutes on April 9, 2025**: Al Krause motioned to approve Monthly Town Board Meeting Minutes from April 9, 2025, without correction. Terry Hock seconded the motion. Motion carried.

Read, correct, and approve the Special Town Board Road Bid Meeting Minutes on April 28, 2025: Al Krause motioned to approve Special Town Board Road Bid Meeting Minutes from April 28, 2025, without correction. Terry Hock seconded the motion. Motion carried.

**Approval of Vouchers:** Terry Hock motioned to approve the vouchers numbered 26266 through 26284 and 11 EFT online payments. Al Krause seconded the motion. Motion carried.

Outagamie County Sheriff Department- Residents' Concerns: No sheriff was present. Resident concerns: Scott Schaumberg reported contacting the Oneida Police Department regarding an individual lying alongside County Road EE.

Discussion was held on the newly installed flashing stop signs at the intersection of County Roads E & EE. The Town of Oneida proposed the safety improvement to the Outagamie County Highway Department. An intergovernmental cost-sharing agreement was approved in March 2025, with installation costs split between the Town and County. The County will be responsible for ongoing maintenance.

Discussion was held regarding recent lost/found dog protocol. The Clerk received a call from the Oneida Police Department Dispatch regarding a lost dog. Dispatch and the Oneida Nation Senior Warden indicated that they only transport lost dogs to the Humane Society when the call originates from a tribal member. As the caller in this case was not a tribal member, assistance was unclear.

Per dispatch, the Outagamie County Sheriff's Department no longer handles lost dog pickups. The Town does not have a trained and certified constable, nor ordinances addressing this service. Discussion included the Town's past use of a constable and how the establishment of the Oneida Police Department changed the protocol.

Residents expressed that all township residents should be served by Oneida Police. Chairperson Schaumberg stated this concern will be brought up at the next Cooperative Governance Meeting with the Town and the Oneida Nation.

**Temporary Class "B" License- Fire Department Picnic June 1, 2025:** Terry Hock motioned to approve the Temporary Class "B" License- Fire Department Picnic June 1, 2025 Al Krause seconded motion. Motion carried.

Temporary Class "B" License- Immaculate Conception Parish on August 17, 2025: Terry Hock motioned to approve the Temporary Class "B" License- Immaculate Conception Parish on August 17, 2025. Al Krause seconded motion. Motion carried.

Fire Department Report: No report provided.

**First Responder Report:** Provided by County Rescue for April 2025; Total calls = 11. Traumatic Injury (3). Breathing Problems (2). Hemorrhage/Laceration (2). Abdominal Pain (1). Back Pain (1). Chest Pain (1). Diabetic Problem (1). Medical Alarm (1). Mobile Integrated Health Care (1). Overdose/Poisoning (1). Sick Person (1). Average Response Time - 11 min.

## **Open Discussion –** Limit 3 minutes per person

Traffic Concerns on Lambie Road. Increased traffic is expected due to upcoming events. The area will be monitored for public safety and emergency vehicle access. Currently, "No Parking" signs are posted on a portion of the east side of the road.

Ken Olson (Hank Olson Construction) evaluated Hanson Road. The surface is breaking apart, though no soft spots were found. Discussion included local stone quotes and availability. Resident concerns of large asphalt chunks potentially causing injury, blocking culverts, or filling ditches. The Board discussed the benefits of delaying final paving until late summer to allow the road to dry, improving longevity. Temporarily graveling the road was considered, though this may cause increased dust for residents for an extended length of time.

Other Road Projects discussion included: Bodart Ct: Will be postponed due to the worsening condition of Moore Road. Residents are concerned of safety factors due to the condition of Moore Road. McCabe Road: Originally planned for reconstruction in 2025, but with the damage to Hanson Road caused by a late winter storm, required reconsideration. One option discussed was to grind McCabe Road in late fall and leave it gravel over winter.

Update on the ditch cleaning project on Ranch Road: Hank Olson Construction will clean the south-side ditch along Ranch Rd/Moore Rd before Oneida Nation contracts Outagamie County for work on adjacent Oneida Trust Land.

**Adjournment:** Al Krause motioned to adjourn at 7:59 P.M. Terry Hock seconded the motion. Motion carried.
