

MONTHLY TOWN BOARD MEETING
TOWN OF ONEIDA, OUTAGAMIE COUNTY
DECEMBER 8, 2021

The meeting was called to order at 7:03 P.M. by Scott Schaumberg

Present were: Scott Schaumberg, Al Krause, Terry Hock and Jennifer Andersen

Also present: BJ O'Connor Schevers, Daniel Garvey, Mary Olson, James Olson, Ken Olson, Lori Olson, Glen Olson Kelly Hill, Mel Van Den Berg

Scott Schaumberg led the Pledge of Allegiance.

Terry Hock made the motion to approve the minutes without correction for the Monthly Town Board Meeting on November 10, 2021 and Special Town Board Meeting on November 30, 2021. Al Krause seconded the motion. Motion carried.

Al Krause made the motion to transfer \$2,000.00 from Capital Expense into Clerk Expense account. Terry Hock seconded the motion. Motion carried. Jennifer Andersen is leaving to go work elsewhere. Kelly Hill accepted the job and will take over on December 28th and Mary Olson is filling in until Kelly feels secure in the job.

Terry Hock made the motion to approve payment of voucher numbered 24910 to 24943. Al Krause seconded the motion. Motion carried.

No one was available from the Outagamie County Police Dept.

Scott Schaumberg made a motion to approve the Election Board Poll Workers for 2022-2023. Terry Hock seconded the motion. Motion carried. List is attached.

Al Krause approved to give a Christmas Bonus of \$50.00 to each Fireperson, First Responder and Employee. Terry Hock seconded the motion. Motion carried.

Scott Schaumberg made a motion to give the Highway Employees \$1.00 raise. Terry Hock seconded the motion. Motion carried. The Clerk/Treasurer received a raise previously.

Discussion was for new Airparks for the fire department. Scott Schaumberg made a motion to table it until next monthly meeting.

Glen Olson, Chief gave fire report of 6 fire calls; 1 Garbage Truck with hot coals, 1 Grass Fire, 1 Car Accident with deer, 1 Pickup Truck with a pole, 1 Car roll over, and 1 CO call, training for November was Air Bags, they had a Fire Truck in Freedoms Parade, they had Fire Prevention on November 17th and had over 100 people counting kids and grownups, Open House on November 18th about 30 people there. Fire Dept had election of officers December 6th meeting, Fire Chief Glen Olson, Assistant Chief Kurt

Olson, Secretary Kyle Vanden Langenberg, Treasurer Kurt Nackers, Captain Joe Maass, Lieutenant Chet Olson, Anna Froehlich was voted the new Fire Board Member with Theo Kurowski.

No First Responder present but Jenny had the report of how many calls they had was 28 the last month.

Open Discussion: One resident asked why Oneida Nation doesn't pay for fire service, Scott Schaumberg replied that they receive \$165,000.00 thru the service agreement and that covers all services. Another resident asked why the town didn't have Grass/Brush drop off. We can burn clean brush. Why doesn't our town have tire drop off weekly or monthly like Freedom? Scott Schaumberg said we have tire drop off twice a year.

Scott Schaumberg asked Ken Olson how the light display was going on his road. Saturday was bad, County Sherriff said signs were illegal.

Terry Hock made a motion to adjourn at 8:04 P.M. Al Krause seconded the motion. Motion carried.
