The meeting was called to order at 7:00 P.M. by Scott Schaumberg

Present were: Scott Schaumberg, Al Krause, Terry Hock and Jennifer Andersen

Also Present: Daniel Garvey, BJ O'Connor-Schevers, Ken Olson, Lori Olson and Glen Olson

Scott Schaumberg led in the Pledge of Allegiance.

Terry Hock made a motion to approve the minutes without corrections for the Monthly Town Board Meeting on September 8, 2021. Al Krause second the motion. Motion carried.

Al Krause made a motion to approve the vouchers, numbered 24853 thru 24885 and three EFT online payments. Terry Hock second the motion. Motion carried.

Outagamie County Sheriff Department – No Deputy was able to attend the meeting this month.

Ken and Lori Olson – Neighbors Christmas Display, parking concerns – Ken stated he is worried about the display on Alpine Drive and parking on both sides of the road. People from all over park and walk across street. Lori is worried a child may get hurt if people are not watching the road and are looking at the display and a child runs in front of a vehicle. The road gets very congested. Ken Olson stated the neighbor with the display contacted Oneida Police Department asking if they could put up signs for “Temporary No Parking” on one side of the road. Oneida Police Department said they do not have the authority to do that and it is up to the Town of Oneida.

After discussion between the Town Board and Fire Chief, Glen Olson; Al Krause made a motion to allow “Temporary No Parking” signs on the north side of Alpine Road at the owner’s expense. Terry Hock second the motion. Motion carried.

Redistricting – Approve County Supervisory Districts and Wards, Signing of Resolution 2021-03 – Scott Schaumberg made a motion to approve and sign Resolution 2021-03. Al Krause second the motion. Motion carried. Below are maps and Resolution 2021-03.

Discuss Budget and Set November Date - Town Board worked on Budget. Scott Schaumberg made a motion to approve the 2022 Proposed Budget and set the 2022 Proposed Budget Meeting date, scheduled for November 10, 2021 at 7:00 P.M. with our November Monthly Meeting to follow. Terry Hock second the motion. Motion carried.

Fire Department Report – Fire Chief Glen Olson stated they had 7 calls in October; 1 Fire Alarm, 1 CO call, 1 car versus steer, 1 lift assist, 1 water alarm, 1 MABAS call with Pulaski and 1 structure fire. Training last month was on gas and CO detectors.

First Responder Report – No First Responder available and Jennifer stated she received the reports from County Rescue. August, the First Responders had 20 calls. Septembers they had 19 calls total.

Open Discussion – Limit 3 minutes per person – Scott Schaumberg asked if anyone had anything. No one had anything to discuss.
