

MONTHLY TOWN BOARD MEETING

TOWN OF ONEIDA, OUTAGAMIE COUNTY

JANUARY 10, 2024

Meeting was called to order at 7:05 P.M. by Scott Schaumberg

Present were: Scott Schaumberg, Al Krause, Terry Hock and Kelly Hill

Also Present: Glen Olson, Riley Olson, Pat Cornelious, Terry Doxtator and Chris Doxtator.

Scott Schaumberg led in the Pledge of Allegiance.

Terry Hock made a motion to approve the Monthly Town Board Meeting on December 13, 2023 minutes without corrections. Al Krause second the motion. Motion carried.

Al Krause made a motion to approve the vouchers numbered 25805 thru 25845 and 8 EFT's. Terry Hock second the motion. Motion carried.

Outagamie County Sheriff Department; no sheriff present. Clerk, Kelly Hill, read an email received from Officer Lee regarding Deputies attendance at town hall meetings.

2023 Budget Expenditures transfer to 2024 budget -The Town Board went over budget and transferred funds as follows: Town Board \$5,084.57 will transfer to Capital Expense. Attorney \$3,000 will transfer to Capital Expense. Clerk/Treasurer \$13,084.55 will transfer to Capital Expense. Elections \$0. Auditor \$0. Town Hall \$8,933.12 will stay. Fire Department Building \$21,568.21 will stay. Insurance & Bonds \$0. The Fire Department \$81,468.63 will stay. First Responders \$4,004.50 will stay. Rescue squad \$1,363.40 will transfer to Capital Expense. Building Inspector \$1,234.00 will transfer to Capital Expense. Service Award Pension \$2,540.00 will transfer to Capital Expense. Hwy Construction and Maintenance \$45,722.45 will stay. Garbage/Recycling will transfer to Capital Expense. Park \$121.27 will stay. Park Fee \$5,311.87 will stay. 2% Fire Insurance Dues \$11,560.85 will stay. Capital Expenses \$377,878.97 will stay.

Al Krause made a motion to transfer 2023 Budget Expenditures to the 2024 budget Scott Schaumberg second the motion. Motion carried.

Fire Department Report given by Fire Chief Glen Olson. (5 calls) Town Rd; Gas smell in house. Sewer gas. No residents are present. HWY 54 & CTY H; 2 car accidents. 2 people were transported. Fish Creek Rd; call for house fire which ended up being burning cardboard. Moore Rd & CTY EE; SUV hit Power Pole. No transport. Cooper Rd; Fire behind his property. Controlled burn.

Last month. All air packs were flow tested (every other year) Monday Night all firefighters that were there were face fit tested for air packs (every year) Year review; 81 calls. 10 MABAS. 42 tribal. 29 non-tribal. 4 structure fires this year.

First Responder Report given by County Rescue and reported by Kelly Hill; Total calls=18. Advanced Life Support =9. Basic Life Support =8. Canceled calls=1 non- transports =3 (17%). Mutual Aid=0. EMRs on-scene=4.

Old Business

Fallen trees in the right of way. Presentation of State Statue 86.03.

Open Discussion – Limit 3 minutes per person

Chris Doxtator discussed the concern of road ditch cutting on Culbertson Rd. The Town Board explained factors of road ditch maintenance including the steepness, trees and water flow of the ditches. The Town Board assured that road ditch maintenance will be improved.

Terry Doxtator discussed her concern of the speed limit of Johnson Rd. Resident suggest the speed limit to be 25 mph due to the curve and pedestrians. The Town Board and maintenance discussed that the Wisconsin Department of Transportation does not allow municipalities to lower the speed limit more than 10mph without specific qualifications, ones in which this situation does not meet. The Town Board suggested cutting back road ditches to improve visibility along with a caution curve sign.

Terry Doxtator asked if the Town has anything in place for trauma debrief. Fire Chief, Glen Olson, stated that trauma debrief would be through County Rescue.

Chris Cornelious requested consideration for the Town to have an Oneida Nation flag.

Al Krause made a motion to adjourn at 8:05P.M. Terry Hock second the motion. Motion carried.
